**THE CAMPUS LIVING VILLAGES’ ACE YOUR SPACE SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ELIGIBILITY: The Campus Living Villages’ “Ace Your Space” Sweepstakes (the “Sweepstakes”) is open to legal residents of the United States (excluding AK, FL, HI and NY) and the District of Columbia, age 18 or older at the time of entry. Void in Alaska, Florida, Hawaii, New York, Puerto Rico, outside the U.S., and wherever else prohibited by law. Employees of Century Campus Housing Management L.P., d/b/a Campus Living Villages (the “Sponsor”) and its respective employees, subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

SWEEPSTAKES TIMING: The Sweepstakes begins at 12:00 am CST on Monday, December 15, 2025 and ends at 11:59 pm CST on Monday, August 31, 2026 (the “Sweepstakes Period”).

You may not enter at the properties which are not participating in the sweepstakes (3rd party managed sites; Northwestern State University – University Columns; Varnado Hall; University Place). Lease must be approved to receive an entry (the “Lease Entry”). Date of Lease Entry will be based on the date the lease is approved by the Sponsor. Each Principal of the lease will receive one (1) Lease Entry. **Lease Entries must be received between 12:00 am CST on Monday, December 15, 2025 and 11:59 pm CST on Monday, August 31, 2026.** Entrants are subject to all notices posted at the Campus Living Villages managed properties including but not limited to the Sponsor’s privacy policy.

Method #2: Mail-in Entry. Mail a letter, including your name, complete address, email address and phone number to: The **Campus Living Villages' Ace Your Space Sweepstakes**, 1001 Fannin St, Suite 1350, Houston TX, 77002. The letter must indicate to which village your entry applies. You can enter at any one of the 8 Participating Properties, but you cannot enter at the properties that will not be participating (3rd party managed sites; Northwestern State University – University Columns; Varnado Hall; University Place;) **The letter must be mailed separately and must be postmarked no sooner than Monday, December 15, 2025 and received by Monday, August 31, 2026. ("Mail-in Entry").** Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsor and will not be returned or acknowledged. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

Limit: One (1) entry per person regardless of the method of entry. Each entrant can only participate at one Participating Property. All entries become the property of the Sponsor and will not be acknowledged or returned. All methods of entry have an equal chance of winning.

- **University of Texas at Arlington - Centennial Court:** \$500 Visa Gift Card, \$200 Visa Gift Card, \$250 Visa Gift Card, \$50 Visa Gift Card, \$50 Visa Gift Card, \$50 Visa Gift Card, \$50 Visa Gift Card, \$50 Visa Gift Card, \$50 Visa Gift Card (total approximate value \$1,250).

Winners will be confirmed via email and/or phone on or around September 30, 2026, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, a W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These releases will require the winners to furnish their Social Security Number for the sole purpose of tax reporting, as required by law. The prize package will be awarded within approximately ninety (90) days after the winner is verified.

If a winner is otherwise eligible under these Official Rules but is nevertheless deemed a minor in his or her state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return Affidavit/Release on minor's behalf.
